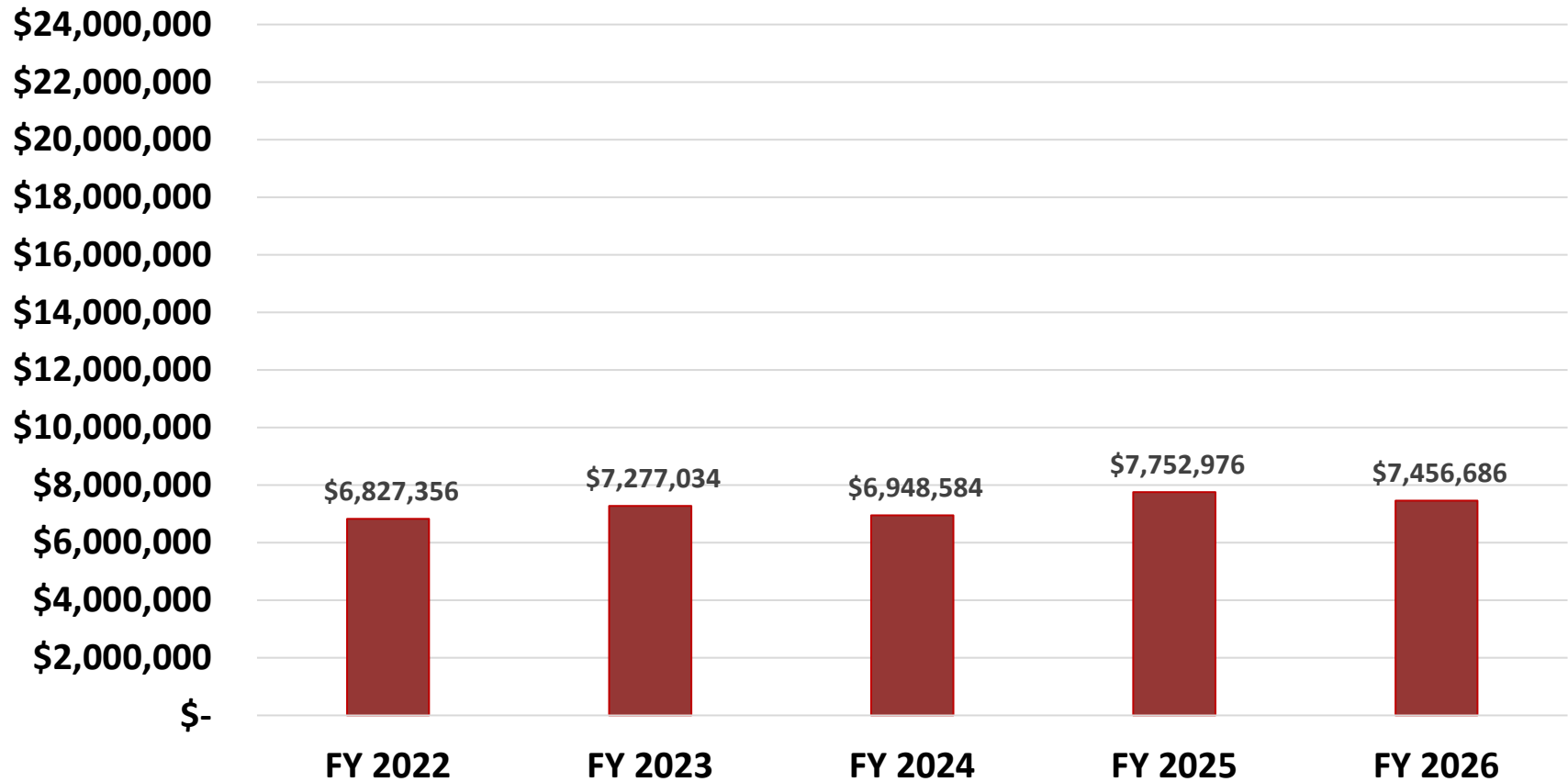

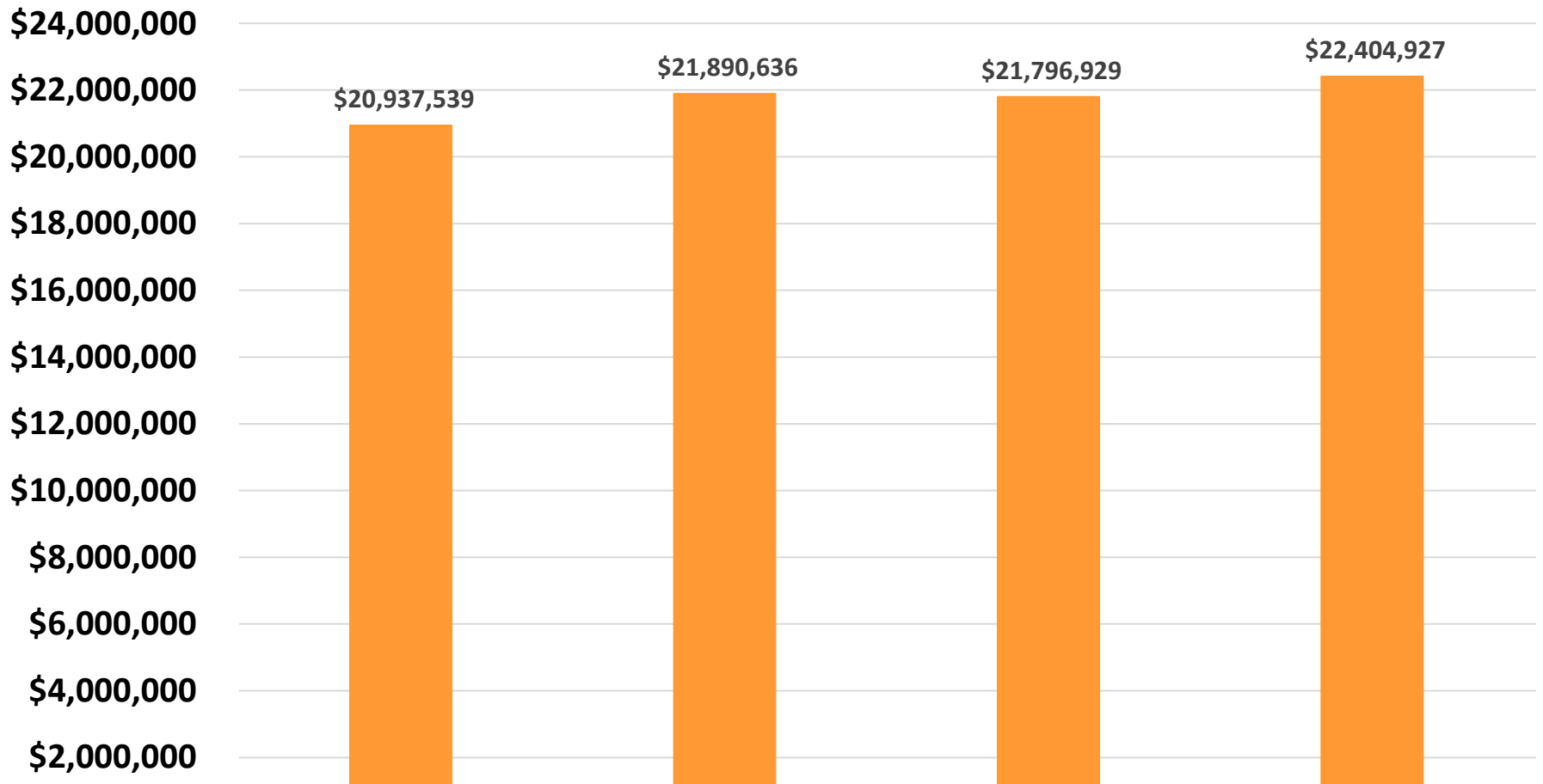
Total Sales Tax Collections

Month to Date



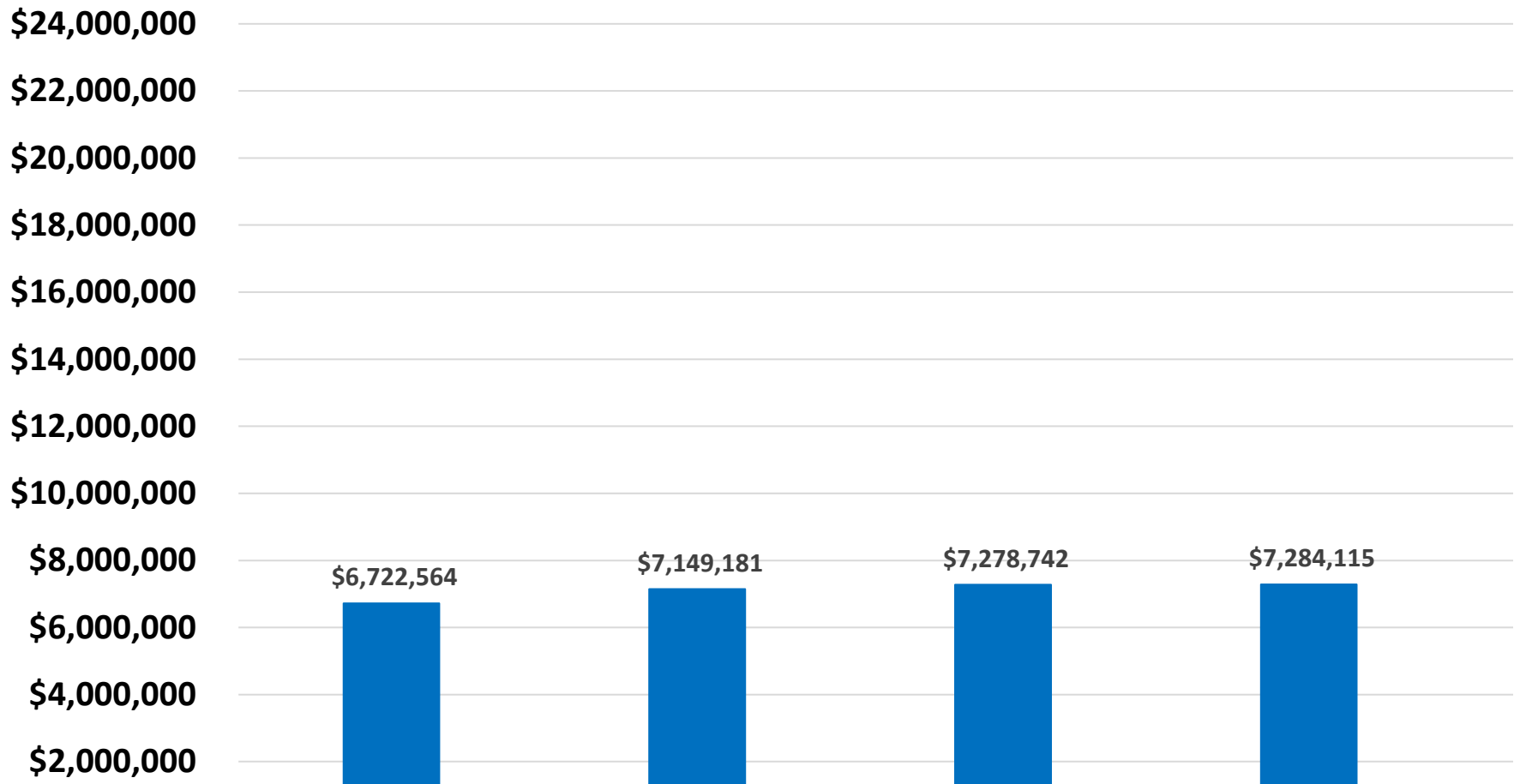
Total Sales Tax Collections

Year to Date



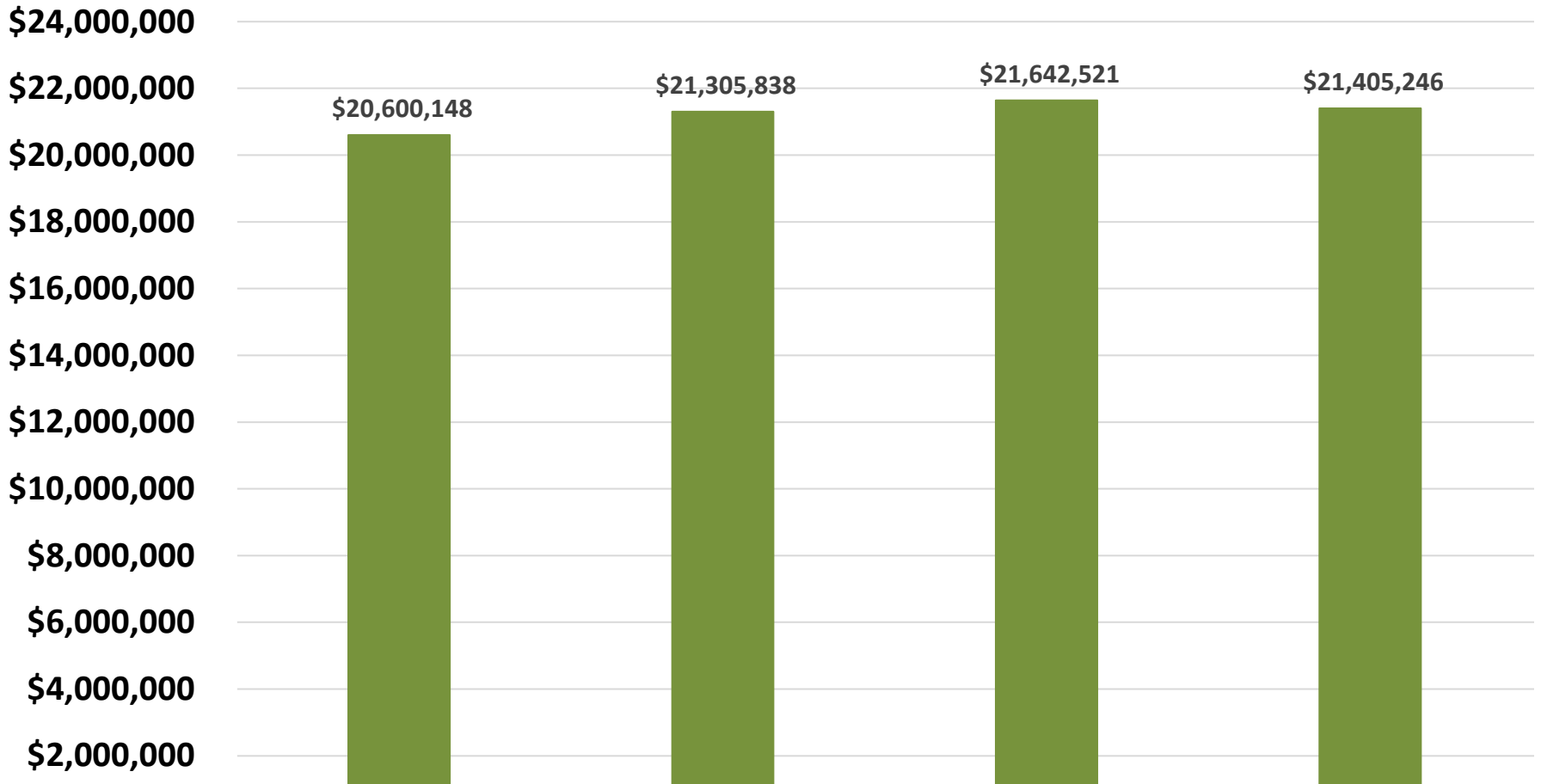
Current Sales Tax Collections
